Membership Types for REALTOR® members of LUTAR

- 1. Primary** - LUTAR is your primary local Association; State and National REALTOR® dues will be included in your LUTAR bill. This class of membership is required if you do not already belong to another local Board/Association.
- 2. Secondary** - You already belong to another local Board/Association and pay your State and National REALTOR® dues through that Board/Association. You must already be a member in good standing of another local Board/Association of REALTORS® to be eligible to apply as a secondary member.
- 3. Gateway** - Brokers from other local REALTOR® Associations wishing to have Realcomp access only must submit a letter of good standing from their primary association along with payment. All licensees licensed under the broker will be assessed the same rate.
